Subject: Industrial Emissions Directive contradicts Raw Materials Supply Security

Dear Heads and Members of Cabinets,

Currently, the trilogue negotiations on the **EU Industrial Emissions Directive (IED)** are entering the final phase.

We, the mining sectors in Europe, are very concerned about the proposal to include mining activities into the scope of the IED. This proposal contradicts the EU agenda on supply security and strategic autonomy, and counteracts the new EU Critical Raw Materials Act.

The IED would lead to more inappropriate burden, higher costs, lengthy permitting, much more bureaucracy and double regulation for the extractive industries in Europe. As a consequence,

raw materials supply and dependencies from outside EU will remain high and investments in Europe will be less attractive.

In our view, the European Commission's proposal does not sufficiently take into account this negative impact for the raw materials supply security in Europe and our sector.

Therefore, we strongly recommend to withdraw the raw materials sector from the IED and re-assess the impact and consequences on a profound basis and in-depth analysis.
